### THE OSBORNE FAMILY

In fairfield during the 18th and first half of the 19th centuries. and in New Haven during the latter part of the 19th century, the Osborne family achieved local prominence. The families into which Osbornes married were of similar stature. During the 19th century among the Osbornes and their relations were a Governor of Connecticut, two judges, several lawyers and successful businessmen and a distinguished scientist.

In 1889 a detailed book of the genealogy of the Osborne family and its relatives was drawn up by Arthur Dimon Osborne (1828 - 1920). Two copies of the published genealogy, one differing slightly from the other, are on the shelves of the Society library and are entitled, "Osborne Family Records." They are not a part of the Osborne Collection, but are important background material. The Osborne Collection consists of ledgers and account books of three generations of Osbornes, and record books of a relative by marriage, Ebenezer Dimon (1763 - 1841). The material was probably donated to the Society library by Thomas Burr Osborne (1859 - 1929) or his widow, or by Arthur Sherwood Osborne (1861 - 1924).

The chronological order in which the ledgers have been filed will be best understood by studying the 1889 Osborne genealogy. A capsule summary of this genealogy as it applies to the ledgers and records at hand is drawn up below.

Jeremiah Osborne 1753 - 1825 m. Anna Sherwood d. 1812

Ebenezer Dimon 1763 - 1841 m. Mary Sherwood Hinman d. 1852

Susan Osborne 1791 - 1885

Thomas Burr Osborne 1798 - 1869 ------m. Elizabeth Huntington Dimon, d.

Jeremiah Osborne: Born in 1753, he enlisted in the continental army early in the Revolutionary War and served with distinction throut the conflict. He participated in several battles and was at Valley Forge and Yorktown. After the war he entered the dry-goods business, first in New York, then in Weston (now Easton), Connecticut and was most successful. Impaired health required him to retire to farming. He was the father of Susan Osborne and Thomas Burr Osborne. He died in 1825.

## THE OSBORNE FAMILY (cont'd.)

Ebenezer Dimon: Born in 1763, he was with his father in the campaign of 1777, near New York. He rebuilt the family homestead in Fairfield after it was burned by the British in 1779. He was Sheriff of Fairfield County from 1806 to 1819, was a founder of Fairfield Academy and the Fairfield public library. His daughter Elizabeth Huntington Dimon married Thomas Burr Osborne. He died in 1841.

Susan Osborne: Born in Fairfield in 1791, she was the daughter of Jeremiah Osborne and the sister of Thomas Burr Osborne. Mention is made of her here because her note-book of household recipes dated 1837 is in the Library's women's collection (MSS #58). She died in 1885.

Thomas Burr Osborne: Born in Weston in 1798, the son of Jeremiah Osborne. He was admitted to the Bar in New Haven in 1820 and commenced the practise of law in Fairfield County. From 1826 to 1839 he held the position of Clerk of the Superior and County courts. He served two terms in the U.S. Congress and then served in the Senate of Connecticut. He served for several years a Judge of the Fairfield County court, and served as Judge of Probate for one year. He married Elizabeth Huntington Dimon.

In 1854 he moved his family to New Haven and taught at the Yale Law School until 1865 when he retired. He died in 1869 in New Haven.

Samuel Smedley Dimon: Born in 1807, the son of Ebenezer Dimon. He was executor of his father's estate and worked with his mother, Mary Sherwood Dimon, in its settlement. He was a delicate person and died in 1854 at the age of forty-seven.

Arthur Dimon Osborne: Born in 1828, son of Thomas Burr Osborne, he received law instruction from his father and was admitted to the Bar in 1850. He moved to New Haven in 1854 where he was Alderman of the 2nd Ward. He was appointed Clerk of the Superior and Supreme courts, remaining in that office until 1882. He held numerous civic posts and business directorships and in 1882 was elected President of the Second National Bank of New Haven. He retired in 1899 and died in 1920 at the age of 92.

Arthur Dimon Osborne took a great interest in the heritage of his family and published the genealogy of the Osborne family and its relatives in 1889. One of his two sons, Thomas Burr Osborne, became a distinguished scientist and was internationally known for his basic research in vegetable proteins at the Connecticut Agricultural Experiment Station in New Haven.

# Box I Affairs of Ebenezer Dimon

- Folder A Letter book of Ebenezer Dimon 1795 1829. This journal is unusual in that it contains copies of letters sent by Dimon. Copies of letters prior to the invention of the typewriter seem the exception rather than the rule. These letters deal with financial transactions and export—import dealings of Ebenezer Dimon with New York, Philadelphia,—and London merchants. The journal also includes a list of expenses after Ebenezer Dimon's death, probably made by his son and executor, Samuel Smedley Dimon. This journal is of particular value because it expresses a sense of the conduct of business at the end of the 18th and beginning of the 19th centuries.
  - B Account book of the estate of Ebenezer Dimon, 1841 1852. Samuel Smedley Dimon, son of Ebenezer Dimon, was executor of the estate, and Mary S. Dimon, widow of Ebenezer Dimon, was beneficiary.
