- VII. Biographical note: The Fairmount Association was incorporated on 26 July 1911 to provide municipal services to the former 32nd Ward in the Annex section of New Haven. Although the 32nd Ward was part of the City of New Haven, it maintained a separate tax rate and independent police and fire services. The Fairmount Association also provided street lighting and refuse removal. The Fairmount Association was dissolved on 31 May 1959 by a special act of the state legislature which provided for full consolidation of the 32nd Ward with the City of New Haven. The text of this legislation may be found by consulting 1959 Special Act 138.
- VIII. Analysis:
The collection consists of 13 boxes comprising approximately 10,040 items. The collection contains the financial and administrative records of the Fairmount Association for the period 1942 - 1959. Also included is a bank statement from April 1932 housed in Box VI, Folder C. Arrangement is chronological with the exception of the Payroll Ledger which is alphabetical according to employee's last name. The numbers in the right-hand column indicate the approximate number of items in each folder.
